

## PROCUREMENT NOTICE

Electric Power Industry of Montenegro (EPCG), the Employer, has received a development loan from the Kreditanstalt für Wiederaufbau (KfW) to be used for the Piva Hydro Power Plant Rehabilitation . The Employer will use a portion of the available funds for the payments of the work to be performed under the contract for which this Invitation to Tender is issued.

The Employer now invites sealed tenders from eligible tenderers for the Rehabilitation and Modernisation of Piva Hydropower Plant, with three units of 120 MVA installed capacity each. Turbines are Francis-type and the first generating unit was commissioned in 1976.

The general scope of the Works shall cover (i) turbine governors, (ii) generator voltage equipment, (iii) auxiliary power supply, (iv) control system, (v) monitoring system and shall include, but not be limited to the following: plant and equipment data acquisition, dismantling of existing equipment and its temporary site storage (disposal), preparation of design documentation, procurement of materials and equipment, manufacturing and testing of the new equipment at factories, packing, transport and storage to the site, insurance of the Works, erection of the equipment, commissioning, trial operation and obligations during defect notification period.

Tendering will be conducted through the international competitive tendering procedure in accordance with a post-qualification procedure, in line with KfW “ Guidelines for the Procurement of Supply and Work Contracts under Financial Cooperation with Developing Countries“ (<https://www.kfw-entwicklungsbank.de/Download-Center/PDF-Dokumente-Richtlinien/Vergabe-E.pdf>).
