Pursuant to article 69 of the Law on Games of Chance (Official Gazette of Montenegro No. 52/04, 13/07, 73/10, 40/11) Elektroprivreda Crne Gore AD Nikšić (hereinafter: EPCG), with Head Office in Nikšić, 2 Vuka Karadžića St, Nikšić, The Company's PIB 02002230, hereby passes the following:

## RULES OF THE GAME OF CHANCE for the prize contest

III Prize fund shall be divided in two rounds.

- The following prizes shall be awarded in the first round:
- 1 New Year arrangement for two, lasting for 3 days, in the hotel "Palas" in Petrovac The value of the arrangement amounts to €798.00.
- 1 New Year arrangement for two, lasting for 3 days, in the hotel "Bianca" in Kolašin The value of the arrangement amounts to €918.00
- 2 arrangements for two persons each, for winter holiday in Kopaonik (from January 16<sup>th</sup> to January 23<sup>rd</sup>, 2015).

The value of arrangements amounts to €1,600.00.

• 3 laptops.

The value of the prize amounts to €1,995.00.

- 5 vouchers for purchase in Voli markets in the value of €200.00 each.
  The value of the prize amounts to €1,000.00.
- The following prizes shall be awarded in the second round:
- Apartment in Podgorica (75 m2), in the value of €78,700.00

- 1 six-day tourist arrangement for the trip to Barselona for two (May 2015).
  The value of the arrangement amounts to €1,160.00.
- 1 five-day tourist arrangement for trip to Pariz for two (May 2015).

The value of the arrangement amounts to €1,160.00.

- 2 iPads Air. The value of the prize amounts to €907.60.
- 5 vouchers for purchase in Voli markets in the value of €200.00 each. The value of the prize amounts to €1,000.00.

IV Total value of the prize fund amounts to € 89,238.60.

V

- Members of the **Golden Team** shall have the right to participate in the first round of the prize contest.
- All customers from the category HOUSEHOLDS that are members of the Golden Team, as well as all customers from the category HOUSEHOLDS who settle their liabilities by December 31<sup>st</sup>, i.e. their debt towards EPCG amounts to €0 on December 31<sup>st</sup>, shall have the right to participate in the second round of the prize contest.

VI. During the prize contest, all bills of the customers from the category of HOUSEHOLDS who have settled all their due debts in accordance with terms stated in the article V, shall be collected in the separate data base, which will be organized by EPCG and the validity of which will be under the responsibility of EPCG. The system of drawing the winners shall be organized by the method of random electronical selection of the collection reference number. 2. On January 21, 2015 as part of the morning show *Dobro Jutro Crna Goro* (Good Morning Montenegro) broadcasted by the Channel 1 of Radio Television of Montenegro between 06:30 a.m. and 09:00 a.m.

IX. The winner draw shall be attended by the Committee including a representative of the Games of Chance Administration, which will supervise the procedure and prepare the corresponding Minutes, on which basis the Report on Winner will be published in the media within the statutory period. The Committee members shall be appointed with a separate Decision.

X. The prize draw shall take place within the morning show *Dobro Jutro Crna Goro* (Good Morning Montenegro) broadcasted by the Channel 1 of Radio Television of Montenegro between 06:30 a.m. and 09:00 a.m.

XI. The prizes will be delivered to winners within 7 days following publishing of the Report on Winner in dailies *Pobjeda, Vijesti, Dan* and *Dnevne Novine*. The prizes shall be presented in the Annex Hall of the EPCG Head Office at 2, Vuka Karadžića St. in Nikšić. EPCG agrees that the winner shall be entitled to transfer the prize to someone else.

It shall not be possible to exchange the merchandize, i.e. service obtained in the prize contest for cash-value of the won merchandize, i.e. service, or for another prize.

Employees of EPCG and members of their immediate families, i.e. spouses and supported children, shall not be able to enter the prize contest.

The deadline for prize claim shall be 7 days following publishing of the Report on Winner in dailies *Pobjeda*, *Vijesti*, *Dan* and *Dnevne Novine*.

XII. During the period of the prize contest, the Organiser and the entrants shall abide by the set rules of the prize contest, excluding any potential modification thereof.

XIII. The rules shall be published and available to all the entrants in dailies *Pobjeda, Vijesti, Dan* and *Dnevne Novine*.

XIV. The Court in Podgorica shall be competent for any dispute arising between the Organizer and the entrants.

XV. Prize fond in amount higher than 500€, which after the prize game isn't given, the organizer is obliged to sell it on public offering, and funds received by the sale to be paid to budget of Montenegro within 90 days from the final day for taking over the prices.

XV. The prize contest under the above rules shall be organised upon acquisition of consent from the relevant institutions.
