2. Subject of public procurement

Procurement of three-phase and monophas counters for the needs of FC Distribucija.

Subject procurement is done as a whole.

3. Public procurement does not anticipate conclusion of framework agreement

4. Estimated value of public procurement (with VAT) is 1.540.000.00 €;

5. Deadline for execution of contract:

Deadline for the delivery is 5 (five) months from the day of signing the contract. Delivery is to be done in equal monthly lots.

6. Payment will be made within 45 (forty-five) days, successive after each monthly delivery.

7. Conditions and suitability of Bidder

Compulsory conditions for participation in the procedure of public bidding:

Each Bidder, in bidding procedure, has to prove the following:

- That it was neither convicted for criminal offences stipulated by this Law, nor any measure of prohibition of carrying out activities that are the subject of public procurement
- That it possesses business-professional capabilities,
- That it regularly settles due commitments arising on the basis of taxes and contributions,
- That it owns economic-financial capability (article 48 Law on Public Procurement),

Evidence on fulfilling compulsory conditions from this item are submitted in the form and format stipulated in article 51. of the law on Public Procurement RMn:

- Evidence the Bidder has not been effectively convicted for felony from article 46 of this Law, and that it has not been passed protective prohibition measure to carry out certain commercial activity- extract from criminal records or appropriate confirmation of authorized body, that is:
 - evidence the Bidder (responsible person in legal entity –nature person) has not been effectively convicted for criminal offence from article 46 of the Law – **Certificate(confirmation) of administration body authorized for police matters** (Police Administration) and certificate **(confirmation) of authorized common court that the Bidder is not in the criminal records of that court,**
 - evidence that the Bidder(especially for **legal entity and especially for unauthorized person in legal sense**) has neither been convicted for commercial offence nor a protection measure on prohibition to carry out certain activity was passed to it– **Certificate(confirmation) of authorized commercial court** (issues for the period *until entering into force of the Law on Accountability of Legal Entities for Criminal Offences – »Off. Gazette RMn«,no. 2/07, - 19th January 2007*)and
 - evidence that the Bidder (legal entity) has neither been effectively convicted for criminal offence from article 46 of this Law nor a protective measure of prohibition of carrying out certain commercial activity was passed to it – **certificate(confirmation) of authorized commercial court** (issues for the period from entering into force of the Law on *Accountability of Legal Entities for Criminal Offences - 19th January 2007*)
- Extract from court, professional or trade register of the state where the Bidder has its headquarters, or valid permit, that is licence of authorized body for professional carrying out of activities,
- Evidence that legal entity is not under bankruptcy or in the procedure of liquidation- certificate from the court, that is, of the authorized body of the state where headquarters is;
- Evidence from the administration body authorized for tax affairs and organizations of pension and health insurance that commitment for paying taxes and contributions has been settled (Evidence that the tax has been paid, Evidence that pension insurance contributions have been paid, Evidence that payment of health insurance contributions has been done)
- Report on accountinga and financial status- balance of success and balance sheet, report of the authorized auditor, in cases where that is stipulated by the Law which regulates accounting and auditing issues, maximum for the last three years, that is, if the company has been registered later, for the period of registration.
- Evidence that payments to the Bidder have not been cut off – appropriate bank certificates, certificate or statement on financial suitability of the bank where legal entity is its client;

If the state in which the Bidder has its registered office does not issue the mentioned evidence, they can be replaced by Bidder's statement under criminal and material accountability, that is, if in the state where Bidder has its registered office does not have legal provisions that refer to statements under criminal and material accountability, the statement of the Bidder given in front of the authorized court or administrative body , or notary.

If Bidder does not submit any of the evidence on suitability anticipated by this call for public tendering and tender documentation, its Bid will be rejected as incorrect.

Possibility of sub-contractors participation is not anticipated.

8. Possibility of submitting alternative Bids is not anticipated.

9. Criteria for selection of the most favorable Bid is the lowest price offered.

10. Time and venue of reviewing tender documentation (collection)

Interested Bidders can collect tender documentation any working day in premises of FC Distribucija Podgorica – Department for Commercial Affairs, from 11 to 14 h, starting from the date of announcing the Call.

Right of participation belongs to Bidders that collect tender documentation. For collection of tender documentation it is necessary to submit the written request and submit evidence on payment in the amount of **100 €**, to giro account of Electric Power Industry Montenegro(Elektroprivreda Crne Gore A. Public opening, where all the interested Bidders are invited to (that is, their authorized representatives) will be held after expiry of ultimate deadline for receiving the Bids 15.05.2008.at 12⁰⁰ h in premises of FC Distribucija Podgorica, ul. Ivana Milutinovića br. 12, Podgorica.

Bids submitted after the stated deadline, as well as these that are not sealed or complete will not be considered.

13. Deadline for making decision on awarding the contract is 30 (thirty) days from the date of opening of the Bids

15. Additional information

Bids should comprise all the evidence in accordance to the Law and Tender documentation.

Together with the Bid, the Bidder is obliged to submit the bank guarantee in the amount of 2% of the total Bid value, as well as the guarantee to be committed to its Bid 60 days from the date of opening of the Bids, and the letter of intention of the bank for good execution of contract in the amount of 5% of total Bid value

The Purchaser can annul the procedure of part of the public procurement in case the need for that part of public procurement terminates, in cases pursuant to article 72 of the Law on PP.

Bidder can, in written form, ask for additional information or clarification in connection with preparation of the Bid, latest 5 days before ultimate deadline for submitting Bids

All additional information or clarification submit in Montenegrin language.

If the Bidder whose Bid is selected as the most suitable one refuses to sign the contract, Purchaser will activate security asset provided with the Bid and gains right to negotiate to second Bidder from the list for the purpose of signing the contract
